#### St. Louis Corvette Club Meeting November 3, 2009 - Sunset Lakes Banquet Center

The meeting was called to order at 7:02pm by Vice-president Jeff Craig. President Theresa Luebcke was absent. The Pledge of Allegiance was recited and everyone was welcomed. Jeff introduced the current board members, all committee chairpersons and immediate past President Ron Hagenow. Gary Murray was introduced as acting Sergeant at Arms in Jean DuPont's absence. Members were reminded to sign the attendance sheet and purchase 50/50 tickets. A sign-up sheet was made available for monthly birthday cakes for next year's meetings.

Members were reminded to place their wrapped Christmas gifts on the tables up front for the green family and the red family accordingly. There were also boxes for members to place their donated canned goods for each family.
