Important Information for Veterans

This topic is not something we like to think about but as a veteran you are entitled for burial at a national cemetery. I have attached a website here: <http://www.cem.va.gov/pre-need/> which gives you all the details on who is eligible for burial at a national cemetery. Recently the VA started a program where you can get pre-certified for burial eligibility. If you think you might want to be buried at a national cemetery this pre-need certificate might be of assistance to your family. I have done this and it takes about two months to get your certificate. You will need an application for both you and your spouse and will need to also send your discharge papers (DD Form 214) indicating you are eligible. If you have any further question let me know.
